Theology Simply Explained — WSC40 "The Moral Law at the Beginning"

Pastor walks his children through Westminster Shorter Catechism question 40—especially explaining how Adam was given the moral law from the beginning.

Q40. What did God at first reveal to man for the rule of his obedience? The rule which God at first revealed to man for his obedience was the moral law.

And he had the moral law of God, generally speaking, he knew himself also to be under moral obligation of obedience to God even in what for him was ceremonial law. That he was not to eat of the fruit of the tree of That was in the middle of the garden.

The center of the garden. That was a ceremonial law. That was something governing. Got ceremonially sacramentally his relationship with the Lord, the special relationship into which the Lord had brought him. This also was the nature, not only of the tree of the knowledge of Good and Evil in, which he would recognize by obeying the ceremonial law that God is the one who determines what is good and God is the one who determines what is evil.

We have a moral obligation to keep the ceremonial law, which is one reason why people who Attempt to be too clever for their own good. They try to say things like, there's no such division of the law, but, of course, there is, there's laws that are connected to priesthoods.

So that the Bible says, of those laws, when there's a change in priesthood, there's change in law. There and there's the law that God thunders with his own voice. The law that God inscribes on tablets with With his own finger. The law that is reaffirmed even in the character of Christ and the repetition.

Of the commands in the New Testament. But there was the moral obligation to keep the ceremonial law.
